Entry requirements

Commencement

Semester 1 (February), or Semester 2 (July) each year

Academic entry requirements for 1+1 into UQ BEL Faculty's 1.5 year Master programs

- Successfully completed bachelor degree in the same discipline with an average grade of at least of 70% (60% is a pass);
- Successfully completed a minimum 1 year of study in the Master program at the College of Management at National Cheng Kung University with a passing average grade or above.

English language proficiency requirements

<u>future-students.uq.edu.au/applying/english-language-proficiency-requirements</u> IELTS 6.5 overall; 6 at least in all writing, reading, speaking and listening; OR TOEFL iBT 87 overall; 21 at least in writing; 19 at least in reading, speaking and listening

Field of study

For students who have previously undertaken studies in business or commerce, entry will only be considered for a field **not already studied** (some exceptions may apply to accounting).

Credit Transfer

students can obtain up to maximum of one semester credit (#8 units, 4 courses) for #24 unit (1.5yr) programs. Credit can only be granted for those courses that achieve a passing grade
